My name is Mohamed Abdurahman Yussuf and I am Ethiopian Canadian citizen .I am the resident of Toronto, Ontario, Canada .I have married in August/09/2007 here at Toronto, Ontario, Canada and I have four children here at Toronto, Ontario, Canada and I thanks to Almighty God. I arrived to Canada on February/25/1992; the Canadian government sponsored me as refugee from Italy, Under the United Nations High Commissioner for Refugees (UNHCR) Law.

On February/1993, I have had joined with Canadian Forces in a good faith. February/1993 during my Canadian Forces training someone in high position in the Army screw me and put me in mental illness. I believe it was Saturday May /1/1993 The Canadian military training took place here at Toronto, Ontario, Canada .after we Canadian soldiers finished morning training, then we Canadian soldiers went for lunch, we all Canadian soldiers line up for lunch room, then Canadian military cook woman gave me a lunch and fruit orange drink. I went the upstairs lunch room then at time I started to take some the orange fruit juice liquid into the mouth and swallow it. At the time I swallow it the orange Juice liquid I shout out or scream out and that is my first Time I was mentally breakdown, since then I spent my

adulthood life in psychiatric hospital here at Ontario, Canada. Since then my life in Canada was upside down.

During my Canadian military training on May/04/1993, I was mentally breakdown and since October/1993 to October/2004, I spent my adulthood life in a psychiatric hospital here at Ontario, Canada.

For your information that I Mohamed Yussuf never ever used alcohol and Drugs and all of this information you can find out my medical records in Ontario hospitals. Please find attached scanned copy of my medical drugs test reports.

Dear the Government of Canada

for your information Since July/1994 to present time the Ontario white police, Ontario Italian, Canadian Vatican church and some Ontario white people against me, As result of that, they put me economic sanctions here at Ontario, Canada, for that reason I cannot find a work here at Ontario, Canada. The Ontario Italian, some Ontario white people, Canadian Vatican Church and Ontario white police against the rights that are guided by the Canadian charter of rights. The Ontario democratic justice system is broken.

For your information on January/28/2010, I was the first mental illness African Canadian filed United States of America asylum against the white Ontario police; I have filed my asylum here at California State. Please the Government of Canada Read my United States of America asylum and here is my United States of America asylum number: USCIS A#A077733208.

Please read here my psychotic journey story way back to January/1994 here at Jewish Canadian community in Ontario, Canada.

On January/1994 ,while I was under a medical psychiatric Doctor care that I lost my mental conscious and I escaped the reality due to mental delusion impaired illness, Since November /1993 to December/1993 I was receiving antipsychotic injection route Intramuscular (IM) every two weeks here at Etobicoke Hospital Psychiatric Unit,Toronto,Ontario,Canada,

Medically scientifically those who suffering from schizophrenia in within six months will suffering reality escaping due to psychotic impaired attacked continued and on middle of January/1994, I have had suffered from impaired delusion psychoses I claimed I was under 12 years old and I asked the Toronto immigration refugee centre here at Yonge st and Dundas in Toronto, Ontario,

Canada for help, the Toronto immigration refugee centre Have asked me where are you from and I told them I came from Africa right now and my name is Malik Joseph Hebrews and I am Jewish Africa and I am 12 years old, I was born in March/1982 and I do not have place to live, in reality my face look like twenty or twenty two years old because I have had just left from the Canadian Army forces here at Ontario, Canada, in that case the 12 years old that I told Toronto immigration refugee centre does not make sense . in any way the Toronto immigration refugee centre called the Jewish Canadian community centre here at Toronto, Ontario and after one hours later the Jewish Canadian community social worker came to the Toronto immigration refugee centre .the Jewish Canadian community social worker asked me how old Am I? I have told them that I am 12 years old and I was born in March/1982 and I was born here at London in the United Kingdom England. few minutes later the Jewish Canadian centre social worker said indeed you are 12 years old I will provided you place to live then the Jewish Canadian community social worker took me to the Jewish Canadian community centre here at Toronto, Ontario, Canada. Then next month I believe it was February /1994 the Jewish Canadian community centre social worker his name is Mr. Ian Wine, The Jewish Canadian community Social worker took me to the Ontario Court here at 60 Queen st West (Old City Hall) in Toronto,Ontario,canada.the Ontario court Judge and the Jewish Canadian community social worker they could not agreed my Abduction (abandoned) case because the Ontario court judge disagreed that I am a 12 years old because the Ontario court judge saw my face unfortunately the Ontario court judge could not help me to ordered me to have a mental health assessment evaluation because all the story which the Jewish Canadian community social worker told Ontario court judge does not make sense. Unfortunately the Jewish Canadian community social worker and I left the Ontario court without any help. The Jewish Canadian community social worker informed that the Ontario

court judge could not believe that you are 12 year old. On February/1994, the Canadian Jewish community they enrolled me elementary school here at Toronto District School Board in the Great Toronto Area, Ontario, Canada, where they put me grade 8 in the elementary school and during March 1994 to May 1994 Toronto District School Board Bus helped me to pick and dropped off at school daily. Unfortunately the Elementary school principal was in stage of confusion because I don't look like 12 years old; in the behind closed door there was disagreement between the elementary school principal and the Jewish Canadian community. Unfortunately the Jewish Canadian community took me to Dentist doctor here at Finch ave west and Bathurst in Toronto, Ontario, the Dentist Doctor did teeth examinations on me after he finish the examination the dentist Doctor told me that you are not 12 years old and you are 22 years old because I can tell your teeth. Fortunately The Dentist doctor declared that I am not 12 years old.

The Jewish Canadian community took me to lawyer to file my Canadian asylum and the lawyer he invited African woman interpreter. The lawyer saw my face but the lawyer was not helpful. The Lawyer has been filed Asylum on behave of myself here at Ontario, Canada. The Jewish Canadian community took me pediatrician medical doctor, Here at St.clair aveWest and Yonge street in Toronto, Ontario, Canada ,the pediatrician Medical Doctor did a physical examination on me and the pediatrician Medical Doctor said you are not 12 years old .the pediatrician

Medical Doctor gave me injection into my upper arm. During January/1994 to May /1994 I don't know what is going on and also I don't know what is Right and what is wrong due to impaired psychotic stage.

In may 1994 my delusion impaired disorder was little bit improved then I have left the Jewish Canadian community and I have moved the capital city of Canada here at Ottawa, Ontario and I used my real name Mohamed Abdurahman Yussuf.in

September/1994, I was hospitalized psychiatric unit in the Ottawa civic hospital here at Ottawa, Ontario, Canada and Ottawa Civic hospital psychiatric white medical Doctor informed me that You Mohamed Yussuf suffering from Parkinson's disease. Since then no Ontario police contacted me regarding this matter but unfortunately I have suffered due to this matter in hardship way in here at Ontario white community here at Ontario, Canada.

The Dentist Doctor saw my teeth and he could not help me? The pediatrician medical doctor did physical examination on me and he saw my face and he could not help me? The Immigration lawyer saw my face he could not help me. So all of these professionals group no one suggested to put me medical psychiatric evaluation, therefore, they did not do their job according to the law. The reason all of these it happened to me was due to delusion impaired attack. June/1994, after I have left from Jewish Canadian community centre. On August /1994, here at Toronto, Ontario, I have had told my family Doctor O'Hara that

I was confused and told the Jewish Canadian community that I am 12 years old and My Family Medical Doctor O'Hara said your face telling that you are not 12 years old, how they believe you; that reason they provided you place to live in. My family Doctor O'Hara still is working as a family Doctor same location here at Toronto, Ontario, Canada.

Dear the the Government of Canada that is what happened to me my psychotic journey way back to January/1994 here at Jewish Canadian community, Toronto, Ontario, Canada.

Now you can see your own eyes that everyone (Medical Doctor, Dentist, Social worker, elementary School principal, Lawyer) in a stage impaired judgment.

All of this information was documented by Ontario police here at Toronto, Ontario, Canada and also all of this you can find out my United State of America asylum case file.

Dear the Government of Canada for your information On September/2000, I went to Cuba for Vacation , While the airplane on air sky in Cuban territory I was mentally breakdown then I was put into immigration detention centre in Cuba because I was mentally breakdown while the Airplane on the sky air .The Cuban Government helped me as human being. Then Canadian Embassy in Havana, in Cuba escorted me from Cuba to Toronto, Ontario, Canada. Now, everything is clear that Cuban government witnessed my mental illness.

On December/2003, The Prime Minister of Canada Jean Chrétien left from the Office.

Now Canada the Liberal party of Canada elected as Prime Minister Paul Martin.

According the secret news information which I received from the White Canadian people was that, it was hard and not possible that Pope John Paul II here at Vatican Church to win his agenda what he wants from me because the Prime Minister of Canada Jean Chrétien never allowed what the Pope John Paul II Vatican Church wants

from me (Mohamed Yussuf). When The Prime Minister Paul Martin becomes the Prime Minister of Canada then the Pope John Paul II won his agenda that what he wants

from me (Mohamed Yussuf). the Pope John Paul II Vatican Church and the Prime Minister Paul Martin there was agreement between the Pope John Paul II Vatican leader and the Prime Minister of Canada Paul Martin, the deal was to invited me a church Vatican ceremony here at Niagara falls, Ontario, Canada on October/2/2004 and if I denied to attend that church Vatican ceremony to destroyed my brain just to put me *dismantled* so I can hanged around in the winter and summer without brain and If I accepted that ceremony and attended that Vatican church here at Niagara falls ,Ontario, Canada then saved from that brain not to *dismantled* and also I am a saint because my brain saved from *dismantled* .On October/2/2004 I went that Vatican church here at Niagara falls, Ontario,canada and I attended Vatican Church ceremony and priest prayed for me and my brain saved from *dismantled* . *The priest said in lower voice Allah is behind you.*

voice which I can heard a clear voice and on that time the member of parliament Mike Sullivan was nearby to Mr.Pual Ferreira about 3 feet away.

Mr.Pual Ferreira is a Member of Parliament staff here at the Member of Parliament Mike Sullivan office and also Mr. Paul Ferreira he is the one who gave me the appointment on June/24/2013, to met with My member of parliament Mike Sullivan here at Weston office in Toronto and also Paul Ferreira was a former Member of provincial parliament in Weston, Toronto,

Canada. Dear the Government of Canada all of this information it will gives you light to see that discrimination is going on against me. Dear the Government of Canada for your information Three years ago here at St.Joseph'S hospital here at Toronto, Ontario Canada, one of the white st.joseph's health hospital Doctor staff informed in hidden way that I can heard a clear voice, The white Doctor said that all white St.joseph's health hospital staff they don't like you, therefore do not came here for help?

**Luqman** Ayah: 34) "Lo! Allah! With Him is knowledge of the Hour. He sendeth down the rain, and knoweth that which is in the wombs. No soul knoweth what it will earn to-morrow, and no soul knoweth in what land it will die. Lo! Allah is Knower, Aware. (34),"

Dear the Government of Canada for your information during 2008 here at Ontario, Canada, my security Officer work here at Toronto, Ontario, Canada, One of the Ontario Italian woman informed me in a very hidden secret way that you Mohamed Yussuf, your wife cannot have a baby girl born, if you have a baby girl born that baby girl her brain will be destroyed by drug needle and this is deal between Canadian Vatican church and this government Canada .this news was shocked to me .on March/17/2010, The Lord Allah gave us a baby girl, my wife delivered a baby girl here at st. The Asian nurse told that the psychiatric Doctor wants to take this medication around 6:00 Am, then I have had accepted the medication

and I have swallowed one tablet of that medication. Few minutes later I fall slept in a ring stage then the white medical psychiatric doctor came to my psychiatric unit room and he started to put me hypnosis stage and the only question have had remembered was that did you know Osama Bin Laden ? And I have told him who Osama Bin Laden is. This hospital they violated my rights of consent and the hospital violated my Rights as Canadian citizen. The White Doctor never told me that he put me hypnosis.
